Rental contract

Contractual terms for renting costumes/products

Contractual partners ar the renter and rentfordance in Stuttgart

1. Rent costs

Rent costs depend on rent periods, quality and accesories of each costume.

2. Booking and prepayment

For each booking the renter is filling out an order form and makes a prepayment of 50,- Euro, which are non-refundable in case of cancellation.

With his signature on the rental contract, the renter agrees to the contractual terms. The full rent costs including the security deposit have to be paid at least 7 days prior to the shipment.

We charge a safety deposit of 30,- Euro per costume, which will be refunded to the renter after returning the rented items.

3. Cancellation

The order can be canceled up to 14 days before the agreed shipping date. A cancellation less than 14 days before the agreed shipping date will be charged with 30% of the total costs for compensation. Entitlement to a refund is lost if the contractual terms are not fulfilled. A refund is not possible, if a costume has been rented but has not been used.

4. Returning

The costume return must happen on the agreed date.

If a rented product is not returned completely till the agreed return date, regardless of the reason, starting the following day, a fee of 30 Euro will be paid, as well as 15% of the complete order costs for each following day.

5. Cleaning, possible damages or loss

Rent4dance is responsible for the cleaning and the charges are included in the rent costs. If the costume needs extensive cleaning, the renter has to pay the costs.

The renter is obliged to return all costumes and accessories in the same condition they were rented.

Possible damages have to be reported at the latest when returning the costumes.

Damages are: tearing, burns, cutting, excessive make-up, removal of buttons, medals, badges or any other accessories or fabric.

The renter has to pay the full value of the product or the reparation costs, if there are damages or loss to the product or accessories.

6. Shipping

All products are sent from rent4dance in Stuttgart via DHL. The renter is paying all shipping costs. The delivery can not be sent to a PO Box. The renter is also responsible for the return shipment. Hats, crowns and other costume parts, that were sent separately, must be sent back the same way.

7. Place of execution and place of jurisdiction

Place of execution and place of jurisdiction is for both parties Stuttgart.

8. Saving clause

If a clause is partialy or fully void, it will not affect the validity of the remaining contract.

Other agreements have to be made in writing.

The rental contract is valid even without the signature of rent4dance.
